2. That work will be performed in accordance with the International Building Codes promulgated by the Greenville County Redevelopment Authority subject to such inspections as deemed necessary by the Redevelopment Authority.
3. That if work performed by the contractor is found to be unsatisfactory by the Redevelopment Authority, or if contract relations between the contractor, homeowner, or other parties is found to be unsatisfactory, that the Executive Director of the Redevelopment Authority may remove the contractor's name from the "Acceptable Contractors Register."
4. The provision of proof of liability, worker's compensation, self-insurance and/or accident insurance acceptable to the Redevelopment Authority.
5. That the contractor will abide by Equal Opportunity provisions of the Civil Rights Act.
