The Consolidated Plan describes the County's Housing and Community Development needs, priorities, resources, and goals over the next 5 years, including the resources and goals for the upcoming FY2025.

The Citizen Participation Plan (CPP) describes the process by which citizens – especially low- and moderate-income citizens of the community where CPD funded activities will take place- can participate in the planning, implementation, and assessment of programs and projects.
